- All amendments issued will be published on the website <http://dud.ar.etenders.in>. It is the prerogative of the bidders to visit the aforementioned site for corrigendum, addendum and amendment notices. These notices have to be read in conjunction with the tender document and have to be signed and submitted in their technical response along with the bid.
- EMD of Rs. 25,000.00 (Rupees twenty five thousand) only drawn on any nationalized/ scheduled Bank in favour of "Chief Engineer-cum-Director, Deptt. of UD& Housing, Govt. of Arunachal Pradesh, Itanagar" shall be submitted.
- Bidders must complete bid submission of Online Tendering System. Otherwise their bids will not be available during Online Tender Opening.


BIDDING DOCUMENTS
